Space and rates are subject to availability at the time of booking and subject to change until space is confirmed. Air tickets are included and are purchased from Alpine Adventures FL. Alpine Adventures LLC CA acts only as a facilitator, and is not responsible, nor accepts any liability, for any and all services or actions associated with said tickets. For participants providing their own transportation, it is the participants responsibility to arrive in time to participate with the group. Prices quoted for Utah are based upon a group size of 12 or more people. Should the group size decrease below 12 people for any segment Alpine Adventures may choose to cancel that segment, or after discussion and agreement with each participant, continue the trip with a rate adjustment. Price or services cannot be guaranteed in the event of any change in government policy, medical emergencies, or force majeure.

Rates include all fees for payment processing. A discount is applied to your trip fee if all payments are made by cash or check.

The final occupancy of a lodging unit determines the rate per person. Please note that single rooms may not be the same size as double rooms. **An initial payment of \$750 is due by October 31, 2023. Your balance is due on November 10, 2023** and will be based on the group size, and rooming arrangements at that time. A late fee of \$150 will be imposed and all lodging and services reserved in your name will be subject to cancellation for balance payments not received by November 10, 2023, Adjustments to your balance caused by changes in rooming arrangements, or group size, may occur after November 10, 2023 and will be credited back, or due, before departure.

In the event of a travel or medical emergency or situation during the trip, the participant is solely responsible for any and all costs associated with the emergency or situation. This includes but is not limited to accommodation and travel expenses, medical treatment, transportation, hospitalization, surgery, medication, and any other expenses that may arise. As a participant, it is important to ensure that you have adequate means, or travel insurance coverage, to cover any unforeseen situations or emergencies. **We highly recommend that you purchase travel insurance before embarking on the tour.**

Name Changes - The name supplied must match the legal name on the traveler's passport. Changes may incur penalties, which we must pass on to the traveler. Any name change requests must be submitted in writing to our office.

Tour Supplier - Most of the travel arrangements and lodging reservations for this trip are made by the same organization we use for the majority of our European and North America trips, Ski Europe/Alpine Adventures FL.

**Nobody wants to cancel from a trip, but sometimes circumstances arise that can keep you from traveling.
If you must cancel from this trip, the following fees will be imposed:**

Unless superseded by the terms of Priority Reservation your deposit, less a \$75 administrative fee is refundable if written notice of cancellation is received before October 20, 2023.

For all cancellations, including Priority Reservation, received:

100 (10/20/2023) to 81 days before January 29, 2024 the fee is \$850 or 75% of the trip fee whichever is greater.

80 (11/10/2023) days or less before January 29, 2024, and "No Shows", no refund will be given.

A \$75 administrative fee will be added to all the above fee amounts. Additional charges may be imposed by the various lodging, (including fees incurred due to the reduction of people in a specified lodging unit, and upgrade fees) resort, airline and transportation vendors, and are not included in the above fees. Be aware that refunds from vendors (when given) are slow and usually take 90 to 120 days, but in some cases may take as much as 180 days or more. There are no refunds for unused portions or services. All cancellations must be in writing and delivered to the Alpine Adventures office. The date of receipt in the Alpine Adventures office determines the effective date of cancellation. In all cases, notice of cancellation is not valid until a confirmation of receipt is delivered to the sender.

Trip insurance is available and strongly recommended.
