Alpine Adventures LLC CA (hereafter referred to collectively as "Alpine Adventures"), is not responsible for typographical errors. Fees, rates, and specifications are subject to change. Prices quoted are per person. Space and rates are subject to availability at the time of booking and subject to change until space is confirmed.

Prices quoted for Big Sky are based upon a group size of 12 or more people. Should the group size decrease below 12 people for any segment, Alpine Adventures may choose to cancel that segment, or after discussion and agreement with each participant, continue the trip with a rate adjustment. Rates, fees, or services cannot be guaranteed in the event of any change in government policy, medical emergencies, or force majeure.

The final occupancy of a lodging unit determines the rate per person. **An initial payment of \$2000 is due by October 1, 2025. Your balance is due on November 20, 2025**, and will be based on the group size, and rooming arrangements at that time. A late fee of \$150 will be imposed and all lodging and services reserved in your name will be subject to cancellation for balance payments not received by **November 20, 2025**. Adjustments to your balance caused by changes in rooming arrangements, or group size, may occur after **November 20, 2025**, and will be credited back, or due, before departure.

Air tickets that are included may be purchased from Alpine Adventures FL. or directly by Alpine Adventures. Alpine Adventures acts only as a facilitator, and is not responsible, nor accepts any liability, for any and all services or actions associated with said tickets. The traveler name supplied must match the name on the traveler's acceptable identification. Name changes may incur penalties, which we must pass on to the traveler. Any name change requests must be submitted in writing to our office.

Any air travel provided may include the use of special airfares which have different restrictions than normally published fares. Alpine Adventures FL. often selects airfares which require advance purchase of tickets which similarly have additional restrictions and are non-refundable. Consequently, after reservations are confirmed, and even before the ticket is issued, changes to your air tickets usually involve penalties, which may equal the entire value of the ticket. In all cases, Alpine Adventures and you must abide by the airline restrictions and penalties. Please note, that once the ticket is issued, it is non-changeable and non-refundable. For participants providing their own transportation, it is the participants responsibility to arrive in time to participate with the group.

During your trip, when a member of Alpine Adventures staff accompanies or meets you, the staff person's responsibility is limited to verifying that the travel components are carried out by the independent hotels, transfer companies, and other companies under contract with Alpine Adventures. At times, an Alpine Adventures staff member may participate in winter sports or other activities with you. The staff person does so as an additional group participant and not as an instructor or guide.

You acknowledge and agree that if a staff person engages in any activity, selects terrain, or otherwise makes any decision regarding an activity, that this action does not indicate that said terrain or activity is suitable for you. You are responsible for your own actions and decisions when engaging in any activity or terrain and will exercise your own judgment based on your physical ability, weather and general conditions, and the nature of the activity.

In the event of a travel or medical emergency or other personal deviation/situation during the trip, you are solely responsible for any and all costs associated with the emergency or deviation/situation. This includes but is not limited to accommodation and travel expenses, medical treatment, transportation, hospitalization, surgery, medication, and any other expenses that may arise. As a participant, it is important to ensure that you have adequate means, or travel insurance coverage, to cover any unforeseen situations or emergencies. **We highly recommend that you purchase travel insurance before embarking on the tour.**

Alpine Adventures and its suppliers may require liability, medical, or other releases to be acknowledged, accepted, and signed by you in order to participate in any or all trip services.

Tour Supplier - Most of the travel arrangements and lodging reservations for this trip are made by the same organization we use for the majority of our European and North America trips, Ski Europe/Alpine Adventures FL.

Nobody wants to cancel from a trip, but sometimes circumstances arise that can keep you from traveling. Our goal is to ensure you feel supported and informed throughout the cancellation experience.

If you must cancel from this trip, unless superseded by the terms of Priority Reservation, your trip fees are governed by the following refund schedule:

120 (9/22/2025) to 86 days before January 20, 2026 the fee is \$1500 or 50% of the trip fee whichever is greater.

85 (10/27/2025) days or less before January 20, 2026, and "No Shows", no refund will be given.

Regardless of date, once ticketed, air fare is non-refundable.

A \$75 administrative fee will be added to all the above fee amounts. Additional charges may be imposed by the various lodging, (including fees incurred due to the reduction of people in a specified lodging unit, and upgrade fees) resort, airline and transportation vendors, and are not included in the above fees. Be aware that refunds from vendors (when given) are slow and usually take 90 to 120 days, but in some cases may take as much as 180 days or more. There are no refunds for unused portions or services. All cancellations must be in writing and delivered to the Alpine Adventures office. The date of receipt in the Alpine Adventures office determines the effective date of cancellation. In all cases, notice of cancellation is not valid until a confirmation of receipt is delivered to the sender.

Trip insurance is available and strongly recommended.
